



**Waitlist Procedure/Priority:** When a spot becomes available in the confirmed field, the TGA will fill that spot with the top ranked waitlisted team in the division respective to the withdraw. Once all waitlisted teams in a specific division have been exhausted, the TGA will then fill the spot in the field with the highest ranked waitlisted team, regardless of division. For example: If a team from the Senior Division withdraws, the highest ranked Senior Division team on the waitlist will be contacted to fill that spot. If there are no remaining Senior Division teams on the waitlist, the highest overall waitlisted team will be contacted. This could be a Championship Division or Super Senior Division team.
